


## EU REACH SVHC Disclosure on Candidate List

REACH (Registration, Evaluation, Authorization and Restriction of Chemicals, EC 1907/2006) is the European Union's (EU) chemical substances regulatory framework. REACH requires BenQ Corporation to provide customers with sufficient information on Substances of Very High Concern (SVHC) contained in products in concentration above 0.1% weight by weight (w/w) to allow safe use of the product.

## UE REACH SVHC Revelación en la Lista de Candidatos

REACH (Registro, Evaluación, Autorización de Productos Químicos, CE 1907/2006) es el marco legislativo de la Unión Europea (UE) sobre las sustancias químicas. REACH exige a BenQ Corporation proporcionar al cliente información suficiente sobre las sustancias extremadamente preocupantes (Substances of Very High Concern, SVHC) en los productos que figuran en la concentración por encima de 0,1% peso/peso (p/p) para permitir el uso seguro del producto.

REACH (Registrierung, Bewertung, Zulassung und Beschränkung chemischer Stoffe, (EG Nr. 1907/2006) ist die neue Chemikalienverordnung der Europäischen Gemeinschaft (EG). REACH verpflichtet BenQ Corporation, Abnehmern und Verbrauchern ausreichende Informationen für eine sichere Verwendung des Erzeugnisses zur Verfügung zu stellen, wenn darin besonders besorgniserregenden Stoffe (Substances of Very High Concern, SVHC) in einer Konzentration von mehr als 0,1 Massenprozent (w/w) enthalten sind.

## **Informazioni EU REACH SVHC sull'elenco candidati**

REACH (Registration, Evaluation, Authorization and Restriction of Chemicals, CE 1907/2006) è un framework normativo sulle sostanze chimiche dell'Unione Europea (UE). REACH richiede a BenQ Corporation di fornire ai clienti informazioni sufficienti sulle SVHC (Sostanze altamente preoccupanti) contenute nei prodotti in concentrazione superiore allo 0,1% in rapporto peso-peso (w/w) per consentire l'uso in sicurezza del prodotto.

## **EU REACH SVHC-kennisgeving over kandidatenlijst**

REACH (registratie, beoordeling, autorisatie en beperkingen ten aanzien van chemische stoffen, EC 1907/2006) is het regelgevend kader voor chemische stoffen van de Europese Unie (EU). REACH vereist dat BenQ Corporation klanten voldoende informatie geeft over zeer zorgwekkende stoffen (Substances of Very High Concern, SVHC) die producten bevatten in een concentratie vanaf 0,1% gewichtsprocent (w/w) zodat het product veilig kan worden gebruikt.
